MINUTES OF THE ANNUAL MEETING OF THE WILBERFOSS PARISH COUNCIL Held on 21st May 2015 at Wilberfoss Community Centre, Main Street, Wilberfoss

1. Present: The Chairman Councillor Lesley Hoyer, Vice Chairman Councillor Dave Smith and Councillors Sue Butterfield and Mike Skelton

Apologies were received from Councillors Chris Clegg, Mandy Brisco and Norma Randall.

2. Minutes of the Annual Meeting of the Wilberfoss Parish Council held on 15th May 2014 were signed as a true record.
3. Election of the Chairman for ensuing year took place. Councillor Hoyer, having served a fourth year, advised that she was happy to continue should nobody else want to step forward. She was duly proposed by Councillor Skelton and seconded by Councillor Smith.
4. Councillor Smith advised that he was happy to continue as Vice Chair, subject to nobody else wanting to take over the role. He was duly proposed by Councillor Skelton and seconded by Councillor Butterfield.
5. The following Council representatives were nominated for the following organisations within the Parish:

The Wilberfoss Community Centre Management Committee – It was agreed that as the Clerk was also the Centre Manager a representative would not be appointed but that she would report when necessary.
The Wilberfoss, Newton upon Derwent and Kexby Playing Fields & Sports Club Association Committee - the Clerk agreed to act as liaison.

The East Riding & North Lincolnshire Local Councils' Association Committee – Councillor Skelton advised k that he was happy to continue in his role.

The Pocklington & Wolds A1079 Campaign – Councillor David Smith and Councillor Mandy Brisco.
The Pocklington & Market Weighton Crime Prevention Panel/Neighbourhood Watch Panel –Councillor David Smith remains a member of the Wilberfoss Neighbourhood Watch Panel so agreed to continue in his role
Pocklington & Market Weighton Community Partnership. Subject to its continuation, Councillors David Smith and Mandy Brisco agreed to represent Wilberfoss Parish Council.

6. The Council's Annual Return was duly completed and signed in readiness for submission to the Audit Commission. It will be displayed on the Council's Notice Boards and on the Parish website. At the internal auditor's suggestion a 5p discrepancy (following an error by Nat West) has been written off.
